  - Has, on December 15, 2004, at least 6,000 hours of working experience in the construction, installation, alteration and repair of private residence elevators.
  - Helper's and Apprentice's must present letter certifying that the applicant is currently employed by an elevator mechanic or a licensed contractor that holds a C7 license.
4. **License Fees:** INCLUDE a license fee of \$150.00 for initial certification, or \$75.00 for renewal on or before September 1st, or they will be charged \$150.00 for renewing an expired license, by check, cashier's check or money order made payable to **Division of Industrial Relations**.
