This meeting may be reconvened if/as required on **Friday, December 22, 2017** commencing at **10:00 o'clock a.m.** and terminating at **5:00 o'clock p.m.** or immediately after conclusion of the matters hereinbelow listed.

"NAC 618.842 Transcript. (1. NRS 618.295) **Hearings must be transcribed verbatim. A copy of the transcript of testimony taken at the hearing, fully certified by the reporter, must be filed with the Board before whom the matter was heard. The Board will promptly serve notice upon each of the parties and interveners of the filing of the transcript.**" (Emphasis added)

3. Additional items to be discussed at the administrative portion of the Review Board meeting are as follows:
 - A. Schedule of hearings on pending cases, calendar and status report.
 - B. General administration and/or procedural issues.
 - C. Discuss matters for next published meeting agenda.
 - D. Public comment:
Jurisdiction of the Review Board is limited to formal adjudication of contested cases emanating from citations issued under the Nevada Occupational Safety and Health Act. Public comment is restricted and not permitted during Review Board contested hearings which are specifically governed by NRS 618, NRS 233B, and NAC 618. No comments may be made regarding a matter that is or may be subject of a formal complaint before the Review Board. The applicable legislation and codified procedures mandate assurance of a fair and impartial administrative hearing, a transcribed record, and a protected appellate process for an aggrieved party to seek redress in the district courts.

4. Any persons with a disability as defined by the Americans with Disabilities Act, and requiring special assistance to participate in the meeting, may contact the Board at least five (5) days prior to the meeting to endeavor the arrangement of reasonable accommodations.
