A link to our website with report forms and instructions were emailed to all workers' compensation insurers in March 2019. Courtesy emails were also sent to third party administrators. The due date for the *Fiscal Year 2018 WCS Workers' Compensation Claims Activity Report (Activity Report)* is May 6, 2019.

NEW IN FY18: PART 1 – CLAIMS INFORMATION has 3 new line items:

Line Q: No. of Claims in which PT Benefits were paid in FY18 (NRS 616C.440)

Line R: No. of Claims paid PT Benefits pursuant to NRS 616C.473 in FY18 (of Q above)

Line S: No. of Claims in which Death Benefits were paid in FY18 (NRS 616C.505)

BACKGROUND

Nevada Revised Statutes (NRS) 616B.009(1) states: "All insurers shall report to the administrator, annually or, at intervals which the administrator requires, all accidental injuries, occupational diseases, dispositions of claims and payments made pursuant to chapters 616A to 617, inclusive, of NRS or regulations adopted by the division pursuant thereto." Additionally, Nevada Administrative Code (NAC) 616B.016 defines what each insurer shall report. The *Activity Report* is the means by which insurers fulfill this statutory and regulatory requirement.

WHO MUST REPORT?

Workers' Compensation Insurers (Active and Inactive)

- Private Carriers Licensed for Workers' Compensation in Nevada (writing and non-writing)
- Self-Insured Employer (Current and Inactive Certificates of Insurance)
- Associations of Self-Insured Employers (Current and Inactive Certificates of Insurance)

All workers' compensation insurers (*Active or Inactive*) must complete and submit an *Activity Report* or the *Statement of Inactivity*. This includes all self-insured employers, associations of self-insured public and private employers, private carriers and employers who provide accident benefits for injured employees pursuant to NRS 616C.265 (also called "ex-meds"). An insurer having no claims activity during the fiscal year must complete the *Statement of Inactivity* in lieu of the *Activity Report*.

Nevada law allows lifetime claim reopening rights to injured workers under certain circumstances. Therefore, inactive insurers who maintain claim files from their active period of insurance must file a report indicating any activity OR no activity on these claims during the year, including expenses due to claim reopening, an ongoing permanent disability status or other miscellaneous claim expenses.
