ADDITIONAL REQUIREMENTS FOR LICENSING/CERTIFICATE OF COMPETENCY

Please note: In addition to enforcing 29 CFR 1910.109, Explosives and Blasting Agents, the Nevada Occupational Safety & Health Administration has adopted, by reference, additional standards for explosives manufacturing. Proficiency in these standards is required to adequately train employees in the various areas of explosives manufacturing in the State of Nevada. Please check the boxes indicating a thorough understanding of the following standards:

- 29 CFR 1910.119: Process Safety Management of Highly Hazardous Chemicals (*refer to NAC 618.5115*).
- 27 CFR 555.201 Storage of Explosives (*refer to NAC 618.5116*).

Per NAC 618.5111, the applicant must attach a copy of the lesson plans and course materials that the applicant will be using to instruct the explosives training course and a copy of the examinations, including answers, that the applicant will be using to instruct the explosives training course.

Per NAC 618.5114, a holder of a Certificate of Competency must, at least 10 days before conducting an explosives training course, notify the Enforcement Section so that the Enforcement Section may audit the course if it so chooses. Notification form can be found on the dir.nv.gov website.

License/Certificate of Competency must be renewed by the holder of the certificate annually, and at any other time that the explosives training which the holder is instructing is updated. It is the responsibility of the holder of the certificate to renew on or before the date of expiration. If there are changes to the training materials, then the application for renewal should be submitted sooner to allow time for the Division to review the changes. Failure to do so could delay renewal of the certificate.
