<sup>4</sup> Persons identified as Hispanic or Latino may be of any race. The race categories shown exclude data for Hispanic and Latino workers. Cases where ethnicity is unknown are included in counts of non-Hispanic workers.

<sup>6</sup> The primary source of a fatal occupational injury is the person, animal, object, or condition that most directly produced the injury.

<sup>7</sup> The secondary source of a fatal occupational injury is the person, animal, object, or condition, other than the source, if any, responsible for initiating the chain of events or exacerbating the harmful event, including failure to prevent or mitigate harm.

<sup>8</sup> CFOI has used several versions of the Standard Occupation Classification (SOC) system since 2003 to define occupation. For complete information on the version of SOC used in this year, see our definitions page at <https://www.bls.gov/opub/hom/cfoi/concepts.htm#standard-occupational-classification-soc>. Cases where occupation is unknown are included in the total.

<sup>9</sup> Includes fatal injuries to persons identified as resident armed forces regardless of individual occupation listed.
