Cases where ownership is unknown are included in private industry counts. Cases classified as foreign government and other government are included in all government counts, but not displayed separately. Cases where industry is unknown are included in the service sector counts.

<sup>2</sup> May include volunteers and workers receiving other types of compensation. Cases where employment status is unknown are included in the counts of wage and salary workers.

<sup>3</sup> Includes self-employed workers, owners of unincorporated businesses and farms, paid and unpaid family workers, and may include some owners of incorporated businesses or members of partnerships.

<sup>4</sup> Persons identified as Hispanic or Latino may be of any race. The race categories shown exclude data for Hispanic and Latino workers. Cases where ethnicity is unknown are included in counts of non-Hispanic workers.

<sup>5</sup> Based on the BLS Occupational Injury and Illness Classification System (OIICS) 2.01 implemented for 2011 data forward.

<sup>6</sup> The primary source of a fatal occupational injury is the object, substance, person, bodily motion, or exposure which most directly led to, produced, or inflicted the injury or illness.

<sup>7</sup> The secondary source of a fatal occupational injury is the object, substance, person, or exposure, other than the source, if any, which most actively generated the source or contributed to the injury or illness.

<sup>8</sup> CFOI has used several versions of the Standard Occupation Classification (SOC) system since 2003 to define occupation. For complete information on the version of SOC used in this year, see our definitions page at <http://www.bls.gov/iif/oshcfdef.htm>. Cases where occupation is unknown are included in the total.

<sup>9</sup> Includes fatal injuries to persons identified as resident armed forces regardless of individual occupation listed.
