N = number of injuries and illnesses during the reference period

EH = total hours worked by all employees during the reference period

20,000,000 = base for 10,000 equivalent full-time workers (working 40 hours per week, 50 weeks per year).

<sup>2</sup> Cases involving days away from work, job transfer, or restriction (DART) are the sum of cases with days away from work (DAFW) and cases involving only days of job transfer or restriction (DJTR). Days-away-from-work cases include those that resulted in days away from work, some of which may also include days of job transfer or restriction. Days of job transfer or restriction cases include those that result in only days of job transfer or restriction.

<sup>3</sup> Based on the Occupational Injury and Illness Classification System 2.01 developed by the U.S. Bureau of Labor Statistics.
