## APPLICATION FOR PERMIT TO INSTALL EQUIPMENT OR APPARATUSES USED IN CONNECTION WITH WATER HEATERS

**THIS APPLICATION IS ONLY USED FOR FUEL-FIRED WATER HEATER SYSTEMS THAT ARE COMPOSED OF MULTIPLE WATER HEATERS THAT COLLECTIVELY HAVE A CAPACITY OF NOT LESS THAN 1,000,000 BTUS. SYSTEMS WHICH ARE ELECTRICALLY FIRED OR HAVE A TOTAL FUEL BURNING CAPACITY OF LESS THAN 1,000,000 BTUS ARE EXEMPT. SEE NAC 455C FOR MORE INFORMATION. A CONTRACTOR MUST RECEIVE A PERMIT PRIOR TO INSTALLING A FUEL-FIRED WATER HEATER SYSTEM WITH A CAPACITY OF 1,000,000 BTUS OR MORE.**

Applicants must provide the following when applying for an installation permit:

- Layout drawing in digital format that shows the location of equipment, clearances, safety systems, etc.
- Other technical documents as required, including shop drawings, Manufacturer’s Data Report, NB403, etc.
- A current license issued by the State of Nevada Contractor’s Board appropriate to the work being proposed.

The fee for the initial operating permit will be invoiced upon completion of initial inspection. Acceptable forms of payment are check, cashier’s check, or money order.

**THE FOLLOWING ITEMS WILL BE INSPECTED AND VERIFIED AS A PART OF THIS INSTALLATION. IN ORDER FOR AN OPERATING PERMIT TO BE ISSUED, ALL FOLLOWING ITEMS MUST BE IN CONFORMANCE WITH APPLICABLE SAFETY CODES.**

- **No refrigeration equipment is installed in the same room as the water heater system.**
- **Rooms over 500 square feet must have at least two means of exit, remotely located from one another. If such a room has more than one elevation, each elevation must have two means of exit, remotely located from one another.**
- **Emergency shut off switches must be located at each exit. These switches must interrupt the flow of gas into the room.**
- **Room must have appropriate ventilation.**
- **Floor drain and water supply lines in the room must meet code requirements.**
- **Carbon monoxide detection/warning systems must be in place and fully operational.**
- **Water heater systems may not be interconnected with boiler systems.**
