## APPLICATION FOR PERMIT TO INSTALL A BOILER OR PRESSURE VESSEL

**A CONTRACTOR MUST RECEIVE A PERMIT PRIOR TO INSTALLING OR REINSTALLING A BOILER OR PRESSURE VESSEL IN THE STATE OF NEVADA**

Applicants must provide the following when applying for an installation permit:

- Layout drawing in digital format that shows the location of equipment, clearances, safety systems, etc.
- Other technical documents as required, including shop drawings, Manufacturer’s Data Report, NB403, etc.
- A current license issued by the State of Nevada Contractor’s Board appropriate to the work being proposed.

The fee for the initial operating permit will be invoiced upon completion of initial inspection. Acceptable forms of payment are check, cashier’s check, or money order.
