### DIVISION OF INDUSTRIAL RELATIONS ADVISORY COUNCIL Minutes of the Meeting, Tuesday, April 02, 2024

#### 1. Call to Order and Roll Call

At 10:07 a.m. on April 02, 2024, the meeting of the Advisory Council for the Division of Industrial Relations (DIR) was called to order by Chairman Paul McKenzie. Roll Call was taken by Marisa Santizo. Paul McKenzie, Robert Benner, Jeff Seavey, Susan Martinez, Vincent Saavedra, and Maureen Ostby attended via WebEx. It was determined a quorum was present. DIR staff present at the Las Vegas Office were Victoria Carreon, Jodi McCollins, Todd Schultz, Christopher Eccles, Brennan Paterson, William Gardner and Marisa Santizo. Jodie Tonkin, and Rodney Neils attended the meeting via WebEx. Sam Taylor from the Attorney General's Office attended via WebEx.

**2. Public Comment** on items to which actions may be taken No items for public comment were raised.

#### 3. Approval of Minutes of Previous Meeting – January 09, 2024.

Susan Martinez made a motion to approve the minutes of the January 09, 2024, meeting as presented. Jeff Seavy seconded the motion. The motion was approved unanimously.

#### 4. FOR DISCUSSION: Division of Industrial Relations Activity Update

a. Administrator's Update (Victoria Carreon)

Administrator Carreon announced that the Las Vegas Office will be moving to a new location approximately in May 2024. Administrator Carreon also discussed Strategic plan development and budget priorities for FY 2026 and FY 2027.

- b. Deputy Administrators Update (Jodie M. Tonkin)
  - Deputy Administrator Tonkin provided a few CARDS enhancement updates. Ms. Tonkin stated that \$2.1 million dollars was provided by Legislature to upgrade the database used by the Workers' Compensation Section. She also discussed enhancement priorities such as creating the capability to make online payments.
- c. Mechanical Compliance Section-MCS (Brennan Paterson)

Brennan Paterson shared that at the end of February 2023, Nevada had 15,578 active elevators and 23,279 active boilers and pressure vessels. Mr. Patterson also discussed that recent enforcement activities at area hospitals have resulted in the discovery of boilers and pressure vessels installed illegally and in substandard fashion, as well as elevators being altered without permit and with poor workmanship and how working with the hospitals dangers have been averted and contractors have been penalized.

- d. Mine Safety and Training Section-MSATS (Rodney Neils)
  - Rodney Neils gave an update on the Mine Safety and Training Section and discussed that 402 safety/health inspections were completed. Mr. Neils also highlighted that they have provided 424 hours of training to approximately 1100 participants.
- e. Occupational Safety and Health Administration-OSHA (William Gardner)

William Gardner shared that Nevada OSHA completed the agency's response to Federal OSHA's FAME audit on 3/14/2024. Mr. Gardner also discussed OSHA's enforcement compared to national averages such as higher average penalties per violation and having higher retention of penalties after issuance.

#### f. Safety Consultation and Training Section-SCATS (Todd Schultz)

Todd Schultz shared that SCATS has completed a total of 544 Safety and Health Consultations. Mr. Schultz also shared that SCATS provided 758 hours of safety and health training with 3,738 participants trained.

g. Worker's Compensation-WCS (Jodi McCollins)

Jodi McCollins discussed a few accomplishments within the Workers Compensation Unit such as policy cancellations being investigated increased by 4% in 2023 to 28,264 statewide. Another accomplishment was that three new positions were approved by the IFC to support SB274 and they are actively recruiting for those positions.

#### 5. Regulations Update (Christopher Eccles)

a. Proposals to repeal, streamline, and clarify regulations pursuant to Executive Order 2023-008

Senior Attorney Chris Eccles explained that regulation drafts for executive order 2023-008 were sent to LCB on 7/27/23 and they have until 7/27/25 to adopt the regulations. R025-23P has an adoption hearing scheduled for 4/08/24. For R026-23I, the Legislative Counsel Bureau is still working on the proposed draft. For R027-23AP and R028—23AP both these regulations were approved by the Legislative Counsel Bureau and became law on February 27, 2024.

#### b. Regulation Implementing Legislation

Senior Attorney Chris Eccles explained that R076-23P makes changes related to SB274 and AB244. DIR staff are currently working with LCB on an amended proposed draft.

#### c. Heat Illness

Senior Attorney Chris Eccles discussed that DIR had a heat regulation that did not pass. They are currently working with stakeholders to develop a regulation. A stakeholder meeting is being held on 4/08/24.

6. Review and comments on OSHA quarterly complaint report for October –December 2023 (NRS 618.336 and NRS 232.600) (William Gardner)






# Item 4: Mechanical Compliance Section Activity Update - Brennan Paterson

# Item 4: Mine Safety and Training Section Activity Update - Rodney Neils

### Major Accomplishments FY 2024

- Enforcement efforts resulted in 550 Safety & Health Inspections, a 23% increase from FY23
- Provided 6,400 consultations/technical assistance, exceeding performance objective goal of 3,600.
- Key positions filled: Safety Specialist-Elko, CAO-Carson City.
- Increased educational outreach on new federal standards for Silica and Mobile equipment.

- Complete a minimum of one full inspection of all active mine sites.
- Reduce workplace injuries, illnesses and fatalities.
- Improve training programs offered to stakeholders.


### **Major Accomplishments FY 2024**

#### 1. JYC America - Inspection 1699567

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

Located at the facility, the employer required employees to utilize a below the hook lifting device (Superior Lift Roll Manipulator, Serial #733, Model: SL3-3-HMC-MHP) that had been modified with welds by the employer, altering the original capacity of the device, and exposing employees to the recognized hazard of being struck by heavy material in the event of the device failing during a lift.

Reference: ASME B30.20 -1999 (Section 20-1.2.2 general Construction, (d) Modifications, Section 20-1.31 Inspection Classification (a)Initial Inspection (2))

Abatement Note: Among other methods, one feasible and acceptable abatement method to correct this hazard is to have the lifting equipment analyzed/tested by a qualified person or manufacturer to determine the load capacity of the unit and rerated.

Proposed Penalty \$5,531.20

#### 2. Red Star Foam - Inspection 1700297

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not ensure that employees were protected from recognized hazards that are likely to cause serious physical harm. Employees were potentially exposed to recognized crush-by injuries created using seventeen storage racks. The steel storage racks were not bolted to the floor. Failure to bolt down storage racks may result in struck-by or crush-by hazards.

Reference: ANSI MH16.1 - 2012, Specifications for the Design, Testing, and Utilization of Industrial Steel Storage Racks, Section 1.4.7 Column Base Plates and Anchors - The bottom of all columns shall be furnished with column base plates, as specified in Section 7.2. All rack columns shall be anchored to the floor with anchor bolts capable of resisting the forces caused by the horizontal and vertical loads on the rack.

One feasible means of abatement is to follow the requirements of ANSI MH 16.1-2012 Specification for Design, Testing, and Utilization of Industrial Steel Storage Racks.

Proposed Penalty \$3,036.00

#### 3. Inline Distributing Co. – Inspection 1707817

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer failed to ensure employees were protected from recognized crushing hazards presented by forklift operation. Employees operated a forklift (brand: Caterpillar, model: GP15N, type: LP) to move pallets and load trucks. Employees did not use the active operator protection device that would protect them in the event of a tip-over that may dislodge or eject the operator. The available active protection device was a seat belt which was present and functional on the forklift.

Reference 1: Section 5.3.19 of ASME B56.1-2004 Safety Standard for Low and High Lift Trucks Section 5.3 Traveling

5.3.19 An active operator protection device or system, when provided, shall be used. Operator protection in the event of tip over is intended to reduce the risk of entrapment of the head and torso between the truck and the ground but may not protect the operator against all possible injury (see para. 7.2.2).

A feasible means of abatement would be to ensure employees always wear a seatbelt while operating forklifts.

Penalty \$4,465.00

#### 4. BakeMark - Inspection 1714932

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not furnish employment and a place of employment which were free from recognized hazards that were causing or likely to cause death or serious injuries physical harm. Employees were exposed to struck-by and/crushed-by hazards presented by pallets of frozen products stored on steel storage racks while working in and around aisle 1-7 in the freezer area of the warehouse. Employees loaded and unloaded frozen palletized products from damaged steel storage racks utilizing a forklift. Approximately 13 industrial storage racks were damaged, dented, the base plates were detached, and diagonal bracing was damaged. Employees retrieving material from the steel storage racks were exposed to serious injuries such as broken bones, internal injuries, and death.

On November 30, 2023, an employee was removing a pallet with a forklift from a steel storage rack located on aisle 1 when the rack collapsed on top of the employee.

Reference: ANSI MH 16.1:2012 Specification for the Design, Testing and Utilization of Industrial Steel Storage Racks. 1.4.9 Rack Damage:

Upon any visible damage, the pertinent portions of the rack shall be immediately isolated by the user until the damaged portion is evaluated by a storage rack design professional. Before allowing the rack to be placed back into service the design professional must certify that the rack system and/or the repaired components have been restored to at least their original design capacity.

One feasible means of abatement is to ensure that damaged industrial storage racks are repaired and replaced in the warehouse.

Proposed Penalty \$10,938.00

#### 5. K2 Design and Fabrication – Inspection 1717801

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not ensure that employees were protected from recognized hazards that are likely to cause serious physical harm in one instance:

Employees were potentially exposed to recognized crush-by injuries created by the use of 78-storage racks. The steel storage racks were not anchored to the floor. Failure to anchor storage racks may result in struck-by or crushed-by hazards. Employees place and remove stock from the shelves by forklift.

Reference: ANSI MH16.1 - 2012, Specifications for the Design, Testing, and Utilization of Industrial Steel Storage Racks. Section 1.4.7 Column Base Plates and Anchors - The bottom of all columns shall be furnished with column base plates, as specified in Section 7.2. All rack columns shall be anchored to the floor with anchor bolts capable of resisting the forces caused by the horizontal and vertical loads on the rack.

Reference: ANSI MH16.2-1984, Manual of Safety Practices; A code of Safety Practices for the Use of Industrial and Commercial Steel Storage Racks.1.4 Base Plates and Anchoring - All columns of racks are to be furnished with bearing plates. The purpose of the bearing plate is to provide for the transfer of column loads to the floor. The base plate design should be consistent with the compressive strength of the concrete as supplied by the user (owner).

Certain racks such as movable shelf racks and stacker racks must be anchored to the floor capable of resisting shear forces caused by the horizontal and vertical loads on the rack and the strength of the building.

One feasible means of abatement is to anchor the racks securely to the ground.

Proposed Penalty \$5,531.00

#### 6. CARPARTS - Inspection 1717896

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not ensure that employees were protected from recognized hazards that are likely to cause serious physical harm. In the parts storage warehouse on Aisle 1, the employer utilized stackable Tier-Rack storage racks (LN-3 - 2,000 lbs. capacity) with no means to anchor the racks to the floor. The stackable racks are used to store heavy auto parts like fenders and tailgates weighing up to 50 pounds. The storage racks were at risk of being tipped over or collapsing due to employees operating powered industrial trucks (Raymond reach cherry pickers model# 550-09C30TT) to store and retrieve automobile parts from the rack measuring up to approximately 15 feet high. Employees operating the PITs were exposed to recognized crush-by injuries in the event of the storage racks tipping or collapsing.

Reference: Section 1.4.7 of ANSI MH16.1: 2012 Specification for the Design, Testing and Utilization of Industrial Steel Storage Racks. Section 1.4.7 Column Base Plates and Anchors. The bottom of all columns shall be furnished with column base plates, as specified in Section 7.1. All rack columns shall be anchored to the floor with anchor bolts, which shall be designed in accordance with Section 7.3, to resist all applicable forces as described in Section 2.1 or Section 2.2.

One feasible means of abatement would be for the employer to anchor the racks to the floor in accordance with ANSI MH16.1-2012.

Proposed Penalty \$14,518.00

#### 7. Red Carpet Moving, Inc. – Inspection 1718410

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not ensure that employees were protected from recognized hazards that are likely to cause serious physical harm from struck-by hazards presented by unsecured storage racks. In the small parcel area, employees picked and placed small parcels from a five-shelf steel storage rack (Model: Ridg-U-Rak RUR-S465). The storage rack columns were not anchored to the floor with anchor bolts. Employees working in the area were potentially exposed to serious injuries.

Reference ANSI MH 16.1 Specification for Design, Testing, and Utilization of Industrial Steel Storage Racks. American National Standards Institute (ANSI) standard MH16.1-2012 (a revision of MH16.1-2008): Specifications for the Design, Testing and Utilization of Industrial Steel Storage Racks.

#### Section 1.4.7 Column Base Plates and Anchors:

The bottom of all columns shall be furnished with column base plates, as specified in 7.1. All rack columns shall be anchored to the floor with anchor bolts, which shall be designed in accordance with Section 7.3, to resist all applicable forces as described in Section 2.1 or Section 2.2.

One feasible means of abatement is to anchor the storage racks to the floor in accordance with ANSI MH 16.1.

Proposed Penalty \$7,813.00

#### 8. NP Sunset - Inspection 1719438

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not ensure that each employee was protected from recognized hazards that are likely to cause serious physical harm. In the Warehouse Liquor room, employees operated Crown (Model No. WP3035-45) electrical pallet jacks and a Blue Giant (Model: BGS30-130) Powered Walkie Stacker to move items such as beverages. The column base plates of two storage racks used to store bottled water and sodas were not anchored to the floor. The employees were potentially exposed to serious crush-by injuries the event the storage rack tipped due to inadvertent contact between the storage racks and the powered industrial trucks.

Reference: ANSI MH16.1: 2012 Specification for the Design, Testing and Utilization of Industrial Steel Storage Racks. Section 1.4.7 Column Base Plates and Anchors:

The bottom of all columns shall be furnished with column base plates, as specified in Section 7.1. All rack columns shall be anchored to the floor with the anchor bolts, which shall be designed in accordance with Section 7.3, to resist all applicable forces as described in Section 2.1 and Section 2.2.

A feasible means of abatement is to anchor the racks to the floor in accordance with the ANSI standard.

Proposed Penalty \$7,590.00

#### 9. CRET LLC - Inspection 1720130

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not ensure employees were protected from recognized hazards likely to cause death or serious physical harm. The employees were exposed to serious hazards presented by unanchored storage racks (model: unknown). Warehouse employees stored a variety of packages, boxes, and material on the storage racks. In all instances, the racks were not anchored to the floor in the following locations:

- 1. Rack aisle 10, located on the north side wall of the warehouse.
- 2. Rack aisle 11, located on the north side wall of the warehouse.
- 3. Rack aisle 5, located on the west side wall of the warehouse.
- 4. Rack aisle 25, located on the south side wall of the warehouse.
- 5. Rack aisle 26, located on the south side wall of the warehouse.

6. Rack aisle 9, located in the central area of the warehouse.

Employees moved and placed materials on the steel storage racks. Employees were exposed to possible struck by and crushing hazards in the event of tipping or collapse of the storage racks due to the unanchored base plates.

Reference: 1.4.7 of ANSI MH16.1-2008 Specification for the Design, Testing, and Utilization of Industrial Steel Storage Racks.

Section 1.4.7 Column Base Plates and Anchors.

The bottom of all columns shall be furnished with column base plates, as specified in Section 7.2. In addition, all rack columns shall be anchored to the floor with anchor bolts capable of resisting the forces caused by the horizontal and vertical loads on the rack.

Proposed Penalty \$13,828.00

#### 10. Wal-mart Assoc. - Inspection 1720735

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

The employer did not ensure that employees were protected from recognized hazards that are likely to cause serious physical harm. Employees were potentially exposed to recognized crush-by injuries created using storage racks. The eight baseplates of the plastic trash steel storage racking, and the front baseplate of the bay OHD-3 rack column were not secured. In the event one of the forklifts struck one of the unsecured racks and caused a partial or full collapse, employees would be potentially exposed to serious physical injuries such as fractures, or death.

A feasible means of abatement would be for the employer to follow the requirements of American National Standards Institute (ANSI) MH16.1-2012 which requires the employer to ensure that column base plates of each storage rack are anchored to the floor in accordance with ANSI 16.1-2012 Section 7.3.

American National Standards Institute (ANSI) standard MH16.1-2012 (a revision of MH16.1-2008): Specifications for the Design, Testing, and Utilization of Industrial Steel Storage Racks, which includes, among others, the following: Section 1.4.7 Column Base Plates and Anchors: The bottom of all columns shall be furnished with column base plates, as specified in 7.1. All rack columns shall be anchored to the floor with anchor bolts, which shall be designed in accordance with Section 7.3, to resist all applicable forces as described in Section 2.1 or Section 2.2.

#### Elevator, Boiler, and Pressure Vessel Enforcement Issues

The MCS has placed a high priority on enforcement of elevator, boiler, and pressure vessel regulations in recent years. However, several challenges remain in effective enforcement. Listed below are the most common enforcement issues faced by the MCS.

- Objects operating without operating permits: Many owners operate their elevators, boilers, and pressure vessels without operating permits. Typically, 25% of objects in the State are operating without a current operating permit in any given month. For instance, in May of 2024, 8,135 out of 23,384 boilers and pressure vessels were operating without permits, while 3,782 of the State's 15,714 elevators were operating without permits.
  - Enforcement begins with reminder letters sent before permit expiration, then 30, 60,
     and 90 days after permit expiration. After 90 days the MCS begins to issue penalties
     on a monthly basis, beginning at \$500 and scaling up month to month.
  - The MCS can issue an emergency order against an object once penalties are found to be ineffective.
  - Such enforcement is a manual operation and requires an investment of time and resources. In the 2024 fiscal year the MCS issued 508 administrative fines totaling \$2,768,000.00. Of this, \$677,560.51 has been collected.
  - Existing enforcement efforts have improved compliance for some owners, but others remain noncompliant. The MCS will continue to explore options for improving compliance.

- Installation of objects without installation permits: The MCS is continually discovering that contractors have installed elevators, boilers, and pressure vessels without first obtaining permits to do so this occurred on 37 separate occasions in FY24 alone, with some contractors being multiple offenders. The MCS penalty structure allows for a fine of up to \$5,000 for the first offense within 24 months up to \$50,000 for the fourth offense within 24 months. The MCS has also asked local building departments to ask for proof of MCS permits prior to issuing certificates of occupancy. While this recommendation has not yet been adopted by local agencies, the MCS will continue to meet with these agencies and discuss ways to collaborate to improve compliance.
- Unlicensed persons working on elevators: Though the MCS has recently gained the ability to issue financial penalties against unlicensed persons working on elevators, the enforcement of NRS 455C.160, which makes such work a misdemeanor, is beyond the authority of the MCS. The MCS has referred several cases to the Attorney General for prosecution, but none has taken place. The MCS will continue to work with the Attorney General's Office and refer cases as appropriate.
- Contractors working without a license or outside of scope: In the last fiscal year the MCS encountered contractors performing work without a contractor's license or, if they have a license, performing work outside the scope of their licenses on 10 separate occasions. Though the MCS can issue limited financial penalties against some companies, real enforcement must come from the Nevada State Contractors Board. Cooperation with the NSCB has improved, and the MCS is participating in the NSCB's Underground Economy Interagency Taskforce. The MCS will continue to refer cases to the NCSB and advocate for enforcement against unlicensed contractors installing elevators, boilers, and pressure vessels.
