The right knee is specifically excluded. 1 2 The total amount requested for reimbursement is \$66,875.62. The amount of reimbursement, after costs 3 were verified, is \$65,586.53. An explanation of the 4 disallowance is attached to this recommendation memo. 5 This request was received from Associated Risk 6 7 Management on January 20th, 2021. Prior history. 8 This employee was working in Texas for Jack 9 Scapel Trucking when on December 24th, 2011 he threw a 10 chain over a truck and injured his left shoulder. 11 The prior history will be taken from Dr. Witt's 12 1.3 PPD evaluation penned on July 20th, 2013. The employee was seen the day of the injury and 14 diagnosed with a left shoulder strain. 15 By February 2012, the employee was suspected to 16 have a rotator cuff or labral tear. 17 A February 13th, 2012 MRI revealed a 18 full-thickness supraspinatus tear and AC joint 19 20 hypertrophy. On March 12, 2012, the employee saw Dr. Metzer 2.1 who recommended surgery. 22 On March 27, 2012, Dr. Metzer performed a left 23 shoulder arthroscopic rotator cuff repair, two 24 fully-threaded suture anchors, subacromial 2.5

- 1 decompression, superior labral debridement with biceps
- 2 tenotomy. Postoperative physical therapy occurred from
- 3 April 5th, 2012 to August 16, 2012.
- On June 26, 2012, Dr. Sledge noted the employee
- 5 | continued to have soreness and weakness in the left
- 6 shoulder.
- 7 On August 17, 2012, the employee was noted to
- 8 | have significant cervical pain and radicular symptoms.
- 9 | Physical therapy was continued from August 21, 2012 to
- 10 October 19, 2012.
- It appears the employee then moved to Nevada.
- 12 An MRI performed on October 12th, 2012 revealed
- 13 evidence of previous anterior dislocation with
- 14 | Hill-Sach's deformity and anterior labral repair. Soft
- 15 | tissue anchors, 1.8-centimeter full-thickness tear
- 16 | supraspinatus tendon at footprint with mild retraction.
- 17 | Markedly heterogenous, somewhat attenuated distal
- 18 | infraspinatus tendon, without discrete linear tear.
- 19 | Tendinopathy, partial tearing subscapular tendon,
- 20 Grade II AC separation.
- 21 On October 19th, 2012, Dr. Cummings determined
- 22 | that the employee would need a repeat left shoulder
- 23 arthroscopy and rotator cuff repair. This was performed
- 24 on December 19th, 2012.
- 25 At the employee's post-op visit on January 14,

1 2013, he was doing well and would stay in a sling until 2 six weeks post-op.

On February 4th, 2013, the employee requested to return to work on February 18. He was to start physical therapy.

On July 2nd, 2013, Dr. Cummings determined the employee had reached maximum medical improvement and was stable and ratable. He had no restrictions.

On July 20th, 2013, Dr. Witt determined the employee had a 14 percent upper extremity impairment which converts to an 8 percent whole person impairment for the left shoulder.

This employee was hired on March 20th, 2019 as a CDL truck driver for the current employer. On November 13th, 2019, he was tightening some straps on a load when the load bar shifted causing his left shoulder to jerk. He also fell onto his right knee in which he had a prosthetic joint.

The employee was seen at Renown Urgent Care on November 16th, 2019 where x-rays of the lift shoulder revealed mild osteoarthritis and postsurgical changes in the proximal humerus with probable calcific tendonitis. He was diagnosed with left shoulder strain and a right knee contusion.

The employee had an MRI on December 19th, 2019 which showed a complete re-tear of the supraspinatus and infraspinatus tendon with approximately 3 centimeters of retraction to the myotendonous juncture, strain of the teres minor muscle, circumferential degeneration of the labrum without disruption of the biceps labral anchor.

The employee's care was transferred to orthopedist Dr. Nair who began treatment on January 2nd, 2020. Dr. Nair noted that the tear may not be repairable or it may not heal at all due to the employee's two previous surgeries.

On March 5th, 2020, Dr. Nair performed an arthroscopic revision repair of a massive tear of the subscapularis, supraspinatus and infraspinatus with extensive debridement of the shoulder labrum.

At a follow-up on April 13th, 2020, Dr. Nair felt the employee was doing well. Physical therapy started on April 16th, 2020 and concluded on July 13th, 2020.

On July 14th, 2020, Dr. Nair released the employee to full duty.

On July 28th, 2020, the employee returned to Dr. Nair with worsening pain and a new limited range of motion without an intervening injury. Dr. Nair noted a possible re-tear.

An August 17th, 2020 MRI revealed a recurrent 1 full-thickness tear of the supraspinatus involving the 2 anterior fibers of the infraspinatus with mild to 3 moderate atrophy of the muscle bellies. A displaced 4 surgical anchor was noted, not previously seen. 5 High-riding humeral head with moderate glenohumeral 6 7 joint degenerative changes and large effusion with chronic appearing Hill-Sach's deformity of the humeral 8 head was also noted. Unchanged diffuse labral 9 degeneration tearing was also noted as well as a 10 high-grade interstitial tear of the long head of the 11 biceps tendon involving both the intra and extra 12 1.3 articular portions. On September 4th, 2020, Dr. Nair noted the 14 15 employee's three prior rotator cuff repairs and recommended conservative management versus consideration 16 of a total reverse shoulder arthroplasty. Dr. Nair 17 performed a joint injection and recommended a functional 18 capacity evaluation. 19 20 On October 7, 2020, the FCE was performed. Ιt 21 stated the employee's physical capabilities are not 22 compatible with his job description as a truck driver. On October 12th, 2020, Dr. Nair reported the 23

employee received only one week of relief from the joint

injection. He also noted that the employee elected to

proceed with the reverse total shoulder arthroplasty.

On November 10th, 2020, a medical record review was performed which indicated a reverse total shoulder arthroplasty is indicated in the employee's situation.

On November 10th, 2020, Dr. Nair noted the employee was waiting for authorization to proceed with the surgery.

TTD was paid in this case from November 16, 2019 to December 18th, 2020.

On December 6th, 2020, Dr. Betz penned a letter for subsequent injury review. He opined that, quote, "Absent the two prior surgeries and chronic pathologies, employee likely would have suffered no more than a left shoulder strain as a result of the subsequent injury incident on 11-13-2019 requiring a brief course of conservative care followed by complete recovery without permanent impairment. However, as a direct result of the prior surgeries, chronic atrophy and significant prior impairment, employee required extensive additional evaluation, surgery and is now facing total joint replacement with its substantial associated permanent impairment."

Consequently, it is reasonable and appropriate to conclude that 95 percent of the costs of this

1 subsequent claim were the result the combined effects of

2 previous surgeries, preexisting pathologies, and the

3 subsequent injury. 5 percent or less of the cost of the

4 subsequent claim were the result of the subsequent

5 | injury alone. The Administrator agrees with this

6 analysis.

Therefore, NRS 616B.578, subsection 1, has been 8 satisfied.

The employee received an 8 percent whole person impairment for the left shoulder as a result of the PPD performed by Dr. Witt on July 20th, 2013.

Therefore, NRS 616B.578, subsection 3, has been satisfied.

On January 28th, 2019, the employee had a medical examination performed as a requirement for his CDL. The employer hired him on March 20th, 2019 as a driver. The medical examination was in the possession of the employer and was forwarded to Associated Risk Management on December 4th, 2020 after a request for subsequent injury purposes. The form states, quote, "Have you ever had surgery?" End quote. The employee stated, quote, "L-E-T, should be left, shoulder. Two knee replacement." End quote. Additionally, it asks, quote, "Are you currently taking medications?" End quote. The employee answered, quote, "Left shoulder."

1 End quote. 2 In fact, the employee had two left shoulder surgeries which resulted in an 8 percent whole person 3 impairment. 4 North Lake Tahoe Fire Protection District vs. 5 Board of Administration does not require the employer's 6 7 perfect knowledge of a 6 percent permanent impairment. It requires an employee's preexisting permanent physical 8 impairment be fairly and reasonably inferred from the 9 written record and the impairment must amount to at 10 least 6 percent whole person impairment. 11 That is the case here. 12 1.3 Based on the document presented, it is reasonable to conclude that the employer was aware the 14 15 employee had a left shoulder surgery from which he was ultimately awarded 8 percent whole person impairment. 16 Therefore, NRS 616B.578, subsection 4, has been 17 satisfied. 18 Subsection 5 does not need to be satisfied in 19 20 order for this claim to be considered for reimbursement 2.1 since the date of injury is after the October 1, 2007 change in the requirements of the statute. 22 23

The patient developed a high fever and it 1 the next day. was found he had an abdominal wound dehiscence which 2 necessitated a laparotomy and closure of the wound on 3 August 1, 2018. Due to the complications of the first surgery, it was decided by Dr. Halki and assistant 5 surgeon Dr. Rembetski that the second, posterior, 6 7 surgery would be postponed for three to six months to allow the patient time to heal. The patient was 8 discharged from the hospital on August 17th, 2018. 9

On March 18th, 2019, Dr. Rembetski performed a robotic transverse abdominis muscle release and primary closure with mesh reinforcement and closure of the abdominal wall over drain.

On March 23rd, 2019, the employee presented to the emergency room because he had bleeding around the surgical site. He was released. On March 23rd, 2019, Dr. Rembetski removed the drain. On April 3rd, 2019, the employee was taken by ambulance to the emergency room because the incision site had opened and was spurting pus and leaking fluid. It was believed he had an abscess. On April 4th, 2019, Dr. Rembetski performed a debridement of the infected abdominal wound and performed a drainage with a Pulsavac lavage. The employee's cultures had heavy staph growth.

Additionally, the employee suffered an acute kidney

1 injury. This was believed to be caused by the sepsis he suffered.

The employee was unable to care for his wound so he was transferred to Tahoe Pacific Hospital for ongoing wound care. While he was there, it was determined that he had congestive heart failure. The employee was released on May 3rd, 2019. He then moved to Arizona.

Once in Arizona, the employee underwent weekly wound debridement at the Yuma Regional Medical Center from May 6, 2019 to March 9th, 2020.

On June 10th, 2020, the employee saw Dr. Halki where it was determined that he would not undergo the second, posterior, surgery for his back due to the complications of the first surgery. Dr. Halki fit the employee had permanent restrictions. Therefore, he was sent to a vocational rehabilitation counselor. The counselor felt the employee could not return to the work force based on his disabilities, age, 71 years old, education and prior work experience, truck driver. The employee was placed on permanent total disability on October 1, 2020.
