recommendation of the Administrator of the Division of 1 Industrial Relations for approval of the following 2 supplemental request for reimbursement from the account. 3 This is case C143-10-05247-01 for Douglas County. 4 And I will turn it over to you, Ana. 5 MS. ARANDA: Thank you. 6 7 Administrator's recommendation. It is the Administrator's recommendation to accept this third 8 supplemental request pursuant to NRS 616B.578 for the 9 lumbar spine. 10 Amount of reimbursement. The total amount 11 requested for reimbursement is \$13,951.89. The amount 12 1.3 of reimbursement, after costs were verified, is \$12,688.04. An explanation of the disallowance is 14 attached to this recommendation memo. 15 Background. This request was received from 16 Robert Balkenbush, Attorney, on July 12th, 2021. 17 This claim was originally approved by the Board on 18 November 20th, 2014. 19 20 This request contained reporting and/or payment 2.1 for the following expenses: ER visit on October 9th, 2019; 22 Pain management appointment with Dr. Goode's 23 office from February 6th, 2020 through 24 February 25th, 2021. 2.5

Drug screening on February 6th, 2020; 1 September 10th, 2020; and February 25th, 2021; 2 Prescriptions from December 11th, 2019 through 3 May 12th, 2021. 4 On October 9th, 2019, the employee presented to 5 Carson-Tahoe Regional Healthcare emergency room 6 7 complaining of left hip pain, abdominal pain, and rectal These are all conditions that are not accepted 8 pain. for subsequent injury reimbursement. A CT scan was 9 performed, which was essentially normal. He was given 10 some Valium and released. 11 The employee continues to treat with Dr. Goode 12 1.3 where he receives MS Contin, Oxycodone and Lyrica for his low back pain. He also routinely undergoes urine 14 drug testing. At his last office visit on 15 February 25th, 2021, Dr. Goode noted the employee is 16 currently treating in the wound clinic for profound 17 lower extremity cellulitis and edema, nonindustrial, 18 pages 1 through 3. 19 20 That is all. 2.1 BOARD CHAIR WACHTER: Thank you for that. We didn't have anybody on the phone. So I 22 don't know if there's anybody here on behalf of the 23 claimant. 24 2.5 MR. ECCLES: We have Mr. Balkenbush, sir.
