DIVISION OF INDUSTRIAL RELATIONS ADVISORY COUNCIL
Minutes of the Meeting, Monday, October 17, 2022

1. Call to Order and Roll Call

At 10:00 a.m. on October 17, 2022, the meeting of the Advisory Council for the Division of Industrial Relations (DIR) via videoconference between Las Vegas DIR and Carson DIR office was called to order by Interim chairman Rusty McAlister. Roll Call was taken by Marisa Santizo. The board member present in the Carson City office was Ian Langtry. Maureen Ostby was present in the Las Vegas office. William Spiegel and Raymond McAlister attended via WebEx. It was determined a quorum was present. DIR staff present at the Las Vegas Office were Victoria Carreon, Brennan Paterson, Stephen Rodgers, Christopher Eccles, William Gardner, and Marisa Santizo. Jodie Tonkin and Jeff Bixler attended in the Carson City office. Karissa Neff from the Attorney General's Office attended via WebEx.

2. Public Comment

No public comment.

3. Approval of Minutes of Previous Meeting – July 15, 2022. Ian Langtry made a motion to approve the minutes of the July 15, 2022, meeting as presented. William Spiegle seconded the motion. The motion was approved unanimously.

4. Division of Industrial Relations Overview and Update (Victoria Carreon)

Victoria Carreon presented a PowerPoint to give an update on the Division of Industrial Relations major accomplishments and budget priorities for FY 2024 and FY 2025.

5. Regulation Update (Christopher Eccles, Brennan Paterson, and William Gardner)

a. Mechanical Compliance Section (Brennan Paterson)

1. **R033-21A:** This regulation has gone through the Legislative Committee and was acted on by the Secretary of State. It has also brought the Nevada Administrative Code in line with the requirements of the statutes regarding water heaters.
2. **R034-21RP1:** This regulation will adopt the hydrogen technology code. The final adoption hearing is scheduled for November 1, 2022.

b. OSHA (William Gardner)

1. **R053-20RA: Heat Illness.** This regulation includes requirements to create a heat illness program at a trigger of 90 degrees Fahrenheit. The regulation was adopted by the Division of Industrial Relations and was sent to the Legislative Commission during their April meeting. There are no further updates at this time.

c. Workers' Compensation (Chris Eccles)

1. **R134-20A:** This regulation was adopted by DIR within the two-year period of being sent to the LCB and is currently pending at the Legislative Commission.

2. **R032-21RPI:** This regulation is set for an adoption hearing that will take place on November 10, 2022.

• Major Accomplishments in 2022

Item 6b: Mechanical Compliance Section: Overview

Brennan Paterson

- The Mechanical Compliance Section (MCS) is the Authority Having Jurisdiction over all elevators, boilers, and pressure vessels in the State of Nevada.
- Staff of 35 inspectors and administrative support personnel
- Regulates over 36,000 active elevators, boilers, and pressure vessels in every city and county across the State, with more coming online every day.
- Issues construction permits, ensures that regular inspections are performed on all equipment, provides technical expertise to the community, and verifies that all elevators, boilers, and pressure vessels in Nevada operate safely and in conformance with adopted codes.
- Responsible for licensing all elevator mechanics, elevator inspectors, and boiler inspectors in Nevada.
- 24-hour emergency response, tasked with investigating all accidents involving elevators, boilers, and pressure vessels.



Item 6b: Mechanical Compliance Section: Key Issues Brennan Paterson

- Non-compliance among some owners of elevators, boilers, and pressure vessels results in a large amount of MCS resources being occupied by enforcement activities.
- Unlicensed contractors install dangerous equipment without MCS oversight, especially in residential applications. The MCS partners with the Nevada State Contractor's Board to address these contractors, though more resources would be beneficial in solving this problem.
- Outdated database software complicates permitting, inspection, and enforcement for boilers and pressure vessels. The elevator database software, on the other hand, is very effective and the MCS is working to expand it to boilers and pressure vessels.
- Continued growth in Nevada results in more regulated objects, which in turn results in increased demand on MCS inspector resources. MCS staffing is static, meaning each inspector must take on more and more work as more elevators, boilers, and pressure vessels come online.
- Wages for elevator and boiler inspectors at the MCS are far below national and industry average, resulting in recruiting and retention difficulties.



Item 6c: Mine Safety and Training Section: Overview

Rodney Neils

- The Mine Safety and Training Section (MSATS) is responsible for enforcing safety and health standards on all active mining operations in the State of Nevada as outlined in NRS 512.170.
- Staff of 14 employees
- Conduct annual inspection for over 250 surface, underground, sand and gravel operations, and extensive mineral exploration drilling projects.
- MSATS, through a federal grant from the Mine Safety and Health Administration provides training to current and future mine employees and contractors.
- 24-hour emergency response for investigating serious accidents as outlined in NAC 512.190.
- District offices in Carson City, Elko, Winnemucca and Las Vegas



Item 6c: Mine Safety & Training Section: Key Issues

Rodney Neils

- Recruiting and retention. Wages for Safety Specialist and Industrial Hygienists below the national average. Hard to recruit qualified and experienced candidates. Constantly lose trained employees to outside entities due to higher pay/benefits.
- Lack of opportunities for promotions and career advancements.

Item 6d: Occupational Safety and Health Administration

Overview

William Gardner



- The Nevada Occupational Safety and Health Administration (NV OSHA) has jurisdictional authority on the enforcement of occupational safety and health standards within private and public sector workplaces in Nevada excluding Federal installations, maritime industries, and most mining operations.
- Staff of 76 employees
- Conduct comprehensive inspections of high-hazard industries through data-supported targeted enforcement efforts and responds to employee complaints, outside referrals, accidents, and fatalities.
- Issue licenses related to photovoltaic and asbestos contractors.
- Approve permits for tower crane erection and dismantling, approve permits of explosive manufacturers, and evaluate the safety component of owner/contractor-controlled insurance programs in support of the Division of Insurance.
- Investigate allegations of employer retaliation through the Whistleblower Unit.
- Conduct surveys of fatal and nonfatal injuries in conjunction with the Federal Bureau of Labor Statistics (BLS) through NV OSHA's BLS unit.

Item 6d: Occupational Safety and Health Administration

Key Issues

William Gardner



- **The primary issues affected NV OSHA are:**
 - Staff retention due to compensation. Higher wages in private sector and municipal public sector.
 - Large volume of new industry and construction projects requiring strategic targeting with a small number of capable inspectors.

Item 6e: Safety Consultation and Training Section

Overview

Todd Schultz



- The Safety Consultation and Training Section (SCATS) manages all functions of the Occupational Safety and Health Administration Consultation program within the State of Nevada. SCATS helps Nevada's small businesses by offering professional safety and health consultation services and training to improve the safety culture of Nevada employers and employees, at no charge.
- **Staffing-** 30 employees
- **On-site Safety and Health Consultation (632 visits)** – SCATS offers on-site consultation services designed to help employers recognize and control potential safety and health hazards at their workplaces.
- **Safety and Health Training (237 classes)** – SCATS safety and health training classes are results oriented with the goal of developing knowledge and understanding of OSHA and State of Nevada safety requirements.
- **Technical Assistance (4049)** – SCATS staff is available by phone during normal business hours should an employer need technical advice.

Item 6e: Safety Consultation and Training Section

Key Issues

Todd Schultz



- Staffing and retention has become a key issue during this fiscal year. We have experienced the highest turnover in over 10 years.
- Training new staff and getting them qualified to conduct consultation visits independently.



Item 6f: Workers' Compensation Section: Overview

Valerie Hall

WCS is comprised of five specialized units that function together to ensure injured workers' claims are processed and paid in an appropriate manner:

- **Staffing**- 56 employees
- **Employer Compliance Unit (ECU)**
 - Employer compliance investigations / Coverage cancellation or lapse investigations
- **Insurer Compliance Unit (ICU)**
 - Benefit Penalty investigations / Subsequent Injury investigations / Uninsured Employers Claims account
- **Audit Unit (AU)**
 - Audits of insurers, Third-Party Administrators (TPAs), Self-Insured Employers (SIEs), Associations / Complaint investigations
- **Medical Unit (MU)**
 - Medical billing appeals / Complaint investigations / Maintain Treating and Rating provider panels / Process PPD requests
- **Research & Analysis Unit (R & A)**
 - Data collection and reporting / WCS Training / Annual Workers' Compensation Educational Conference / Claims indexing



Item 6f: Workers' Compensation Section: Key Issues

Valerie Hall

- **Cost-of-Living Adjustments**
 - Insurers may request reimbursement for annual 2.3% COLAs for Survivor Benefits (injuries prior to 7/1/2019) and Permanent Total Disability (injuries prior to 1/1/2004)
 - Reimbursement is funded by assessments on all Nevada workers' compensation insurers
- **Challenges include:**
 - Delinquent COLA Assessment payments delay WCS' ability to reimburse insurers
 - Ensuring all claimants who are entitled to COLA increases are receiving them
- **Employer Compliance**
 - Employers must have workers' compensation coverage
 - Subcontractors, independent contractors and their employees are deemed employees of the principal contractor for purposes of the Nevada Industrial Insurance Act
 - Failure to comply may result in administrative fines, premium penalties, stop work orders
- **Challenges include:**
 - Non-compliance increased during the pandemic due to economic strain on businesses
 - Educating business owners about what constitutes an "employee" for purposes of workers' compensation
 - Significant increase in stop work orders and administrative actions

Nevada Revised Statute 618.375(1): Duties of employers. Every employer shall furnish employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his or her employees.

Located at the jobsite, 1315 Mesa Drive, Fernley NV: The employer failed to furnish a place of employment which was free from recognized hazards that was likely to cause death or serious physical harm to employees. Employees installing 18' ductile iron water pipe into a precast vault using a hydraulic excavator (Link-Belt model 250x4 serial #LBX250Q7NMHEX1737) were allowed to perform work within the excavator's operating swing radius, exposing employees to a struck-by hazard from the excavator bucket.

References: A) The employer's Toolbox Talk, Avoiding Ground Level Hazards lurking at Excavation Sites, states "keep your distance from excavation equipment equipped with buckets, such as front-end loaders, backhoes and excavators, as the bucket can strike you as it is raised, lowered, or makes a sudden swing. Never assume the equipment operator sees you standing nearby." B) Link-Belt operating & Safety manual chapter 2-3 "the safety area is the space necessary for the excavator to operate at the maximum range of the tool and a full 360-degree swing plus six feet" and chapter 4-3 "Do not allow anyone within the excavator's operating radius. Stop all operations until everyone has moved away." C) The NIOSH Publication, Preventing Injuries When Working with Hydraulic Excavators and backhoes Loaders, which states "Make all workers on the site aware of the machines' established swing areas and blind spots before the operator works the machine. Keep workers on foot outside these areas by marking them with rope, tape, or other barriers."

Abatement: Among other methods, feasible and acceptable means of abatement include, but are not limited to: Refer and adhere to the following documents and publications; The employer's toolbox, Avoiding Ground Level Hazards Lurking at Excavation Sites, The Link-Belt operating and Safety manual Chapters 2-3 and 4-3, and The NIOSH Publication, Preventing Injuries When Working with Hydraulic Excavators and Backhoe Loaders.

Abated during the inspection: Resource development management team provided an outline for new training standards that included excavator equipment simulator training, a daily job hazard analysis (JHA) for each site and project and retraining documents for all employees. The training documents and the daily JHA included the topics for safe work practices in trenching and excavation and excavator awareness.
