You are hereby given notice that the NEVADA OCCUPATIONAL SAFETY AND HEALTH REVIEW BOARD will conduct a public hearing on Wednesday, April 14, 2021, and Thursday, April 15, 2021, commencing at 9:00 a.m. This meeting will be held *via* a Webex meeting only.
