

Reduce fatalities, injuries, occupational illnesses and accidents to the greatest extent possible by performing the statutory requirements set forth by the Nevada Revised Statutes, Chapter 512.

## What We Do:

#### SAFETY SERVICES

- Provide safety consultations and technical assistance.
- Provide courtesy mine inspections.
- Investigate mine accidents and complaints.
- Provide electrical ground tests.
- Explosives storage evaluations.
- Other services possible upon request.

#### TRAINING SERVICES

- 24 Hr. New Miner (part 46 & 48) online/in-house
- 8 Hr. Annual Refresher (part 46 & 48) online/in-house
- 24 Hr. Instructor (Blue Card) In-house only

#### **INDUSTRIAL HYGIENE SERVICES**

- Provide air sampling (silica, lead, silver, mercury, welding fumes, etc.)
- Provide noise evaluations and surveys.
- Provide ventilation surveys, air velocity and volumetric airflow.
- Provide mine gas surveys and evaluations.
- Advise on hazardous chemical use and storage.
- Provide hazardous material identification and risk assessments.
- Provide respirator training and fit testing.
- Recommend personal protective equipment.
- Provide workplace health evaluations.
