### ANNUAL REPORT OF COMPLIANCE AUDITS OF WORKERS' COMPENSATION INSURERS PURSUANT TO NRS 616B.003

Dear Honorable Members of the Nevada Legislature:

NRS 616B.003(1) requires the Administrator of the Division of Industrial Relations (DIR) to conduct, at least every five years, an audit of all insurers who provide workers' compensation insurance benefits to injured employees. Pursuant to NRS 616B.003(4), the Administrator is to provide a report of each audit to the Legislature, if it is in session, on or before March 1 of each year. If the Legislature is not in session, the Administrator issues the report to the Interim Finance Committee.

The following is a report of the audits conducted by the Workers' Compensation Section (WCS) of the DIR during the period of January 1, 2022 through December 31, 2022, pursuant to NRS 616B.003. Included in the report are the Executive Summaries of each of the audits conducted and the calendar year 2023 Projected Audit Schedule. The audits covered 89 insurers (39 private carriers and 50 self-insured employers).

Each audit focused on the following major areas:

- Timely determination of claim acceptance.
- Timely evaluation and offer of permanent partial disability.
- Accuracy of calculations and payments of temporary partial disability (TPD), temporary total disability (TTD), permanent partial disability (PPD), and/or permanent total disability (PTD) compensation.
- Timely and accurate payment of medical bills in accordance with the Nevada Medical Fee Schedule or as otherwise contracted.
- Timely payment of initial compensation.
- Vocational rehabilitation benefits.
- Use of approved forms.
- Claims administration practices.
- Notification of the right of appeal concerning determination(s).

A total of 605 claims were reviewed. Below is a summary of the violations identified in the 58 five-year audits by category and the percentage of violations out of the total claims reviewed:

The Division is also required to review lung and heart disease claims that have been in the appeals process longer than 6 months to determine the circumstance causing the delay in processing the claim, pursuant to NRS 617.455 and NRS 617.457. Findings from this review are included in the report. 83% of claims from July 14, 2018 to June 30, 2021 were in the appeals process for longer than 6 months as of August 30, 2021. A summary of the reasons for continuance is shown below.

### INTRODUCTION

### 1. PURPOSE

The purpose of this report is to comply with NRS 616B.003(1) and make a report of each audit to the Legislature on or before March 1 of each year. NRS 616B.003(1) requires that the administrator of the Division of Industrial Relations (DIR) "cause to be conducted at least every 5 years an audit of all insurers who provide benefits to injured employees pursuant to chapters 616A to 616D, inclusive, or chapter 617 of NRS."

This Report of Compliance Audits is provided to the Members of the Interim Finance Committee, pursuant to NRS 616B.003(4), which requires the administrator to, on or before March 1 of each year, "make a report of each audit to the Legislature, if it is in session, or to the Interim Finance Committee if the Legislature is not in session."

NRS 616B.012(1) indicates that, generally, "information obtained from any insurer, employer or employee is confidential and may not be disclosed or be open to public inspection in any manner which would reveal the person's identity." NRS 616B.012(7) provides that, in specified circumstances, the disclosure of information from files of claims or policyholders is a gross misdemeanor.

Pursuant to NRS 616B.012(1), information obtained from any insurer, employer or employee which would reveal the person's identity has not been included in this report.

### 2. OBJECTIVE AND SCOPE

#### **OBJECTIVE**

In accordance with NRS 616B.003 (1) the Workers' Compensation Section (WCS) of DIR conducts an audit of each workers' compensation insurer at least every five years.

The objectives of the audits are: 1) to identify and correct violations of statutes and regulations relating to the rights and benefits of injured employees, and 2) to determine if procedures are in place to ensure injured employees receive all benefits to which they are entitled in a timely manner.

Specifically, each audit focuses on the following major areas:

- Timely determination of claim acceptance.
- Timely evaluation and offer of permanent partial disability.
- Accuracy of calculations and payments of temporary partial disability (TPD), temporary total disability (TTD), permanent partial disability (PPD), and/or permanent total disability (PTD) compensation.
- Timely and accurate payment of medical bills in accordance with the Nevada Medical Fee Schedule or as otherwise contracted.
- Timely payment of initial compensation.
- Vocational rehabilitation benefits.
- Use of approved forms.
- Claims administration practices.
- Notification of the right of appeal concerning determination(s).

While the main objectives of the audits focus on insurer and third-party administrator performance, audits may also include employer and employee interviews to ensure employers are complying with such requirements as displaying the proper posters, the ability to provide proof of insurance, and employee notification of rights and responsibilities. Verification of the completion and maintenance of C-1 (Incident Report) forms are also included in the employer site visits.

Some of the areas identified above directly affect the timely and accurate delivery of benefits to injured employees such as the calculation and payment of TTD, PPD, TPD and PTD. Other areas may have less of a direct effect on the benefits received by injured employees such as the claims administrator using an outdated form. All areas are monitored, however, to ensure that the entities within the regulatory authority of the DIR (insurers, employers, third-party administrators, medical providers and organizations for managed care) are compliant with workers' compensation statutes and regulations.


### SCOPE

The audits were conducted during calendar year 2022, included workers' compensation claims dated from July 1, 2019 to June 30, 2020 and July 1, 2020 to June 30, 2021.

### 3. SUMMARY OF FIVE-YEAR AUDITS

In calendar year 2022 a total of 70 five-year audits were conducted which impacted 89 insurers and resulted in a review of 605 claims. Additionally, DIR performed a review of Lung and Heart Disease Denied Claims in the Appeals Process in accordance with NRS 617.455, Section 10 and 617.457, Section 15.

Here is a breakdown by type of insurer for the 2022 audit cycle:



The difference between the total number of five-year audits (70) and total insurers, is as follows:

- Private Insurers Two insurers required a separate audit because the claims administration of claims was shared between two different administrators.
- Self-Insured Employers One self- insured employer required a separate audit because the claims administration of claims was shared between two different administrators.
- Associations of Self-Insured Employers A total of 26 self-insured employers belong to 4 different associations.

Out of the 70 audits, 94% of those insurers outsource the administration of claims, as follows:



The top three third-party administrators representing the largest percentage of insurers are:

- 1. Sedgwick Claims Management Services, 26%
- 2. Cannon Cochran Management Services, 11%
- 3. Gallagher Bassett Services, 11%

A total of 605 claims were reviewed, and below is a summary of the violations identified in the 58 five-year audits by category and the percentage of violations out of the total claims reviewed:

### Benefit Correction/Monetary Recovery:

In the claim files reviewed, the Division identified approximately \$59,222.67 in underpayments to injured employees, no underpayments to health care providers, approximately \$31,927.02 in overpayments to injured employees and no overpayments to health care providers by insurers.


The Division requires underpayments to be rectified by the insurer at the time of the audit, unless the findings are disputed, and additional research is required for resolution. Insurers may recover overpayments made to health care providers in the form of refunds or adjustments. Insurers may recover overpayments made to injured employees pursuant to NRS 616C.155.

#### Administrative Action:

The DIR is authorized to impose administrative fines, issue notices of correction and/or request plans of corrective action for violations of Chapters 616A through 617 of the Nevada Revised Statutes. The DIR is also authorized to impose benefit penalties for certain violations as referenced in NRS 616D.120. As a result of the 5-year audits conducted in 2022 pursuant to NRS 616B.003, the DIR issued administrative fines totaling \$153,300. Plans of corrective action were required to be submitted by insurers for each audit with reportable findings. There were no violations referred to the WCS Benefit Penalty Unit for further investigation.





#### 5. SUMMARY OF FINDINGS, REVIEW OF LUNG AND HEART DISEASE CLAIMS

#### INTRODUCTION

#### 1. BACKGROUND

In accordance with NRS 617.455, Section 10 and 617.457, Section 15, the Division of Industrial Relations shall review claim files that have been in the appeals process for longer than 6 months to determine the circumstance causing the delay in processing the claim. The Department of Administration, Hearing Division oversees the appeal process and provides the Division of Industrial Relations, Workers' Compensation Unit a listing of denied claims for the periodic review.

#### 2. OBJECTIVE AND SCOPE

#### **OBJECTIVE**

To identify claims in the appeal process for longer than 6 months and determine the circumstances causing the delay in accordance with NRS 617.455, section 10 and NRS 617.457, section 15.

#### **SCOPE**

The period covered by the review is July 14, 2018, through June 30, 2021, and only claims processed by the Hearings Office in Las Vegas and does not include claims processed in Northern Nevada.

#### 3. SUMMARY

Out of ninety-three (93) claims identified in the scope of the review, seventy-eight (78) or 83% were in the appeals process for longer than 6 months as of August 30, 2021.

#### 4. RESULTS

A total of 78 claims were identified as being in the in the appeals process for longer than 6 months. It was determined that the most frequent reason for delays is medical questions and/or medical propounding discoveries, which accounts for 32 claims or 41% as noted in the table below.

The second most frequent reason is due to consolidations of two or more appeals filed for the same claim, 17 claims fall under this category. Additionally, 7 claims have been delayed due to the lockdown and office closures. Other less frequent reasons for continuance include scheduling conflicts, absence, technical issues, and the need for an expert witness or testimonies. Of the 78 claims, 28 remain open as of the review date.


NRS 617.455 10(a) and NRS 617.457 15(a) specify in part that the appeals process "Begins on the date on which the claimant first files or submits a request for a hearing or an appeal of a determination regarding the claim". Table 2 shows the number of claims processed per year considering two variables: the year on which a hearing request is filed, and the year on which an appeal is filed, both regarding the same claim. The majority of the requests for hearings and appeals were filed within the same calendar year, 11 requests for hearings and appeals regarding the same claim were filed in different calendar years.



#### **METHODOLOGY**

To gain an understanding of the claim data provided by the Department of Administration, Hearings Division, we interviewed the senior appeals officer, and obtained data from their information technology representative.

The data provided by the Hearings Division Office included 93 denied claims.

NRS 617.455 (10a and 10b) and NRS 617.457 (15a and 15b), indicate that the Appeals Process begins on the date on which the claimant first files or submits a request for a hearing or an appeal of a determination regarding that claim; and continues until the date on which the claim is adjudicated to a final decision. Additionally, NRS 617.455 (11) and 617.457 (16) indicate that the review is of denied claims filed by a claimant.

The scope of the review included lung and heart disease denied claims covering the period of July 14, 2018, through June 30, 2021. The data provided by the Hearing Division included the following: First names and last names of injured workers, date of injury, employers, TPAs, type of health condition, Claim/Hearing/Appeal number, filling and decision date for each claim while being processed by the Hearings and Appeals Office, results, reasons for continuance and comments.

The data included a total of 93 claims, we reviewed the data and identified 78 claims with occupational *disease defined* as lung or heart, 68 of these claims were identified as heart disease, 8 claims identified lung disease, and 2 cases were both heart and lung disease.

Of the total 93 claims, 15 claims were not subject to review because 6 claims were processed in less than six months, 4 claims were not related to heart or lung disease, and 5 claims were filed before the effective date of October 1, 2017<sup>1</sup>.

Our review includes a quantitative approach that was applied to determine the number of claims that meet the criteria by calculating a variable named "Number of days in Litigation" which was compared to the six (6) months threshold. The total number of days in litigation was calculated as the sum of the number of days at the Hearing Office and the number of days at the Appeals Office.

**No of Days in Litigation** = No of Days at HO + No of Days at AO

After determining the number of claims that were in litigation for longer than six (6) months, a qualitative approach was applied to exclude those claims that were not labeled as lung or heart disease. Additionally, claims filed before the effective date, October 1, 2017, were excluded from the review.

Next, the reasons for continuance were grouped by frequency into 8 categories: medical question/propounding discovery, claims consolidation, unknown/unspecified, lockdown/office closure, expert witness HRG/Claimant to testify, scheduling conflict, failed to show, and technical issues.
